Title: Implementation of the Doha Political Declaration: Strategies for cross-sector collaborations and integrated approaches

Background

The Doha Political Declaration at the Second World Summit for Social Development, held on 4-6 November 2025, Qatar, was another landmark achievement. The intergovernmental consensus on the declaration showed that the world is united in further pursuing social development values and goals: peace, poverty eradication, full employment and decent work, social integration, climate change mitigation and adaptation and digital access to all.

Although significant progress has been made in these areas, the social, environmental and economic problems persist. Many people experience poverty, injustice, and discrimination and find it hard to overcome challenging life circumstances, while witnessing the concentration of wealth and prosperity in others. Multidimensional poverty analysis shows that over a billion people are still in poverty. The climate crisis exacerbates poverty, and the digital divide further contributes to inequality. Conflicts and wars stall progress and demoralise people, causing significant loss, grief and stress.

In her Doha Political Declaration address, the President of the General Assembly, Annalena Baerbock, stated: “Social development is not a ‘nice to have’, nor an act of charity. It is in the self-interest of every country.” UN Secretary-General Antonio Guterres said the Declaration is a “booster shot for development.” Although the declaration includes provisions relating to implementation, follow up and review, it is not clear how every country will take determined actions to advance concrete, integrated, and coordinated policies and programs to achieve social development for all.

Focusing on collaboration, active participation, peer learning, and a shared future, the proposed side event will bring together the International Consortium for Social Development (ICSD, non-government organisation); United Nations Research Institute for Social Development (UNRISD, a UN multilateral agency); UN Special Rapporteur on the right to development, the Centre for Social Development (CSD), Washington University, St. Louis (higher education sector); the International Council on Social Welfare; and the NGO Committee on Financing for Development to organise a panel discussion to explore the

implementation of the Doha Political Declaration and strategies for cross-sector collaboration and integrated approaches.

Objectives:

The main objectives of the proposed side event are.

- To raise awareness of the Doha Political Declaration, and commitments and actions needed.
- To explore how multiple sectors--government, nongovernment organisations, business, universities, and civil society—can work together to implement the Doha Political Declaration.
- To discuss the challenges and strategies for cross-sector collaboration and integrated and coordinated approaches.
- To brainstorm policies and programs needed to facilitate multisector collaboration and cooperation.
- To consider ways and means of capacity building across these sectors and conducting research, training and evaluation to develop evidence-based policies.

The side event will deliberate the following two main questions:

Deliberative questions

- What are the challenges and strategies for cross-sector collaboration, and for integrated and coordinated approaches, in implementing the Doha Political Declaration?
- What innovative and participatory policies and programs are needed to enhance capacity at various levels, enabling collaborative, integrated, and coordinated approaches to achieve social development for all?

Expected Outcomes

The side event is expected to achieve the following outcomes:

- Collaboration among the partnering organisations, cross fertilisation of ideas, peer learning, and support.
- Greater awareness of the Doha Political Declaration while creating urgency to move from consensus to action.
- Identification and analysis of challenges to collaboration and integrated and coordinated action.
- Deliberation on effective strategies to enable collaboration and integrated and coordinated action.

- Consideration of innovative, participatory, and locally oriented policies and programs to accelerate the implementation of the Doha Political Declaration, thereby making progress towards social development for all.
- Development of a concise outcome document summarizing key insights, recommendations, and next steps from the panel.
- Potential Establishment of a cross-sector working group or network to continue collaboration beyond the event.
- Commitment to follow-up activities such as webinars, regional consultations, or joint research projects.

Format

A carefully and diligently constituted panel of globally leading social development scholars, policymakers, practitioners, and researchers will make presentations in line with the objectives and questions set out for deliberation. The panel speakers' presentations will be followed by questions, comments and contributions from participants.

Prof. Ramanathan brings more than four decades of experience as a practitioner, educator, and administrator. His work focuses on cross-cultural practice, social development, and corporate social responsibility.
